

Case Study 4: Ellie – Quick Win Within 72 Hours

Background

Ellie was brand-new to running her own practice. She had left a national chain to start her own tax business, but like most new firm owners, she quickly realized the hardest part wasn't filing returns — it was finding clients willing to pay for premium services.

Her biggest challenges:

- ⊗ **No marketing system:** She had no audience or ad budget to attract advisory clients.
